



RACE TERMS AND CONDITIONS, REGISTRATION AND LIABILITY WAIVER

I understand that cycle sport is dangerous, and that I have read, and will adhere to the rules of Ready Steady Riders – Racing.

I certify that the participant is physically capable of completing the course unaided, and has not been advised otherwise by a qualified medical person.

I acknowledge that I the parent/guardian am responsible for carrying any prescribed emergency medicines for known allergies and conditions.

I acknowledge that this Accident Waiver and Release of Liability (Ready Steady Riders) form will be used by event holders, sponsors and organizers, in events in which my child may participate and that it will govern the actions and responsibilities of myself and the participant at said events.

I hereby consent for the named child to receive medical treatment which may be deemed advisable in the event of injury, accident and or illness during this event, by a trained first aider.

I understand that at this event or related activities, I may be photographed. I agree to allow my photo, video or image likeness to be used for any legitimate purpose by the event holders, producers, sponsors, organizers and or assigns.

I understand that I assume responsibility for the mechanical soundness of the participants bicycle and its parts, including but not limited to tires, handle bar ends, bushes, barings, and bolts. I have examined or will examine the bicycle and certify that it is properly assembled and fit to ride. I accept responsibility for damaged or lost equipment.

I understand that I assume responsibility for the participants personal protective equipment. I agree to ensure the participants helmet is in good repair, fit for purpose, meets European safety standards, and is fitted and fastened correctly. I agree to ensure the participant wears appropriate PPE including gloves, footwear, elbow and knee pads.

I, the undersigned, hereby certify that I am the parent or guardian (Parent) of the child (Participant) indicated on this form, and, in exchange for the right of the Participant to participate in events and activities of Ready Steady Riders, relating to or occurring during the Ready Steady Riders race event, and for me to enter into the participants' area, give the following release and waiver. I hereby bind myself and the participant claims and/or damages to the terms and conditions of this release and waiver. In addition to SC, this release and waiver applies equally to the Event Location and Employees Parent expressly agrees that Releasees shall not be liable for any damages arising from personal injuries sustained by Parent or Participant on or about the premises of Releasees or any area under control of Releasees or as a result of Parent or Participant using the facilities and equipment therein. Parent accepts full responsibility for any such injuries or damages which may occur to Parent or Participant on or about the premises or area under control of Releasees. Parent assumes full responsibility for any injuries, damages or losses which may occur to Parent or Participant and forever releases and discharges Releasees and their owners, employees, and agents from any and all.
